Scope of Work:

Projects that may be authorized under the Architectural Term Agreements may involve reconfiguration of buildings to accommodate unique program functions in typical SUNY hospital, academic, research, service and facilities buildings, some of which may be historic. The project scopes may include modifications to building structure, partitions, and envelope and building system modifications and replacements including mechanical, electrical, plumbing, fire protection and communication systems. During construction, provide field administration, inspection, progress reports and manage biweekly progress meetings. The planning scopes may include investigation and comparative analysis of design scenarios, building conditions, space requirements, construction phasing and impact analysis, cost estimates, and other services, as directed.

The projects will involve the replacement, modification or repair to roofing, roof structure, skylights, parapets, facades, soffits, windows, doors, and other exterior construction required to correct water infiltration problems, energy loss, construction failures, and other types of building envelope deterioration in typical SUNY academic, research, service and facilities buildings, some of which may be historic. The projects scopes may include modifications to building structure and building system modifications and replacements including mechanical, electrical, plumbing, fire protection and communications systems. The planning scopes may include investigative assessment of the underlying causes of exterior conditions, design build bridging documents, construction phasing and impact analysis, cost estimates, and other services, as directed, to verify the integrity of facades, roofing, structural systems and other exterior envelope components in existing buildings, parking garages, or plazas/terraces.
